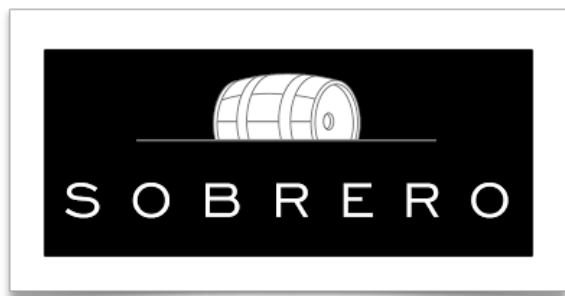

## AZIENDA AGRICOLA SOBRERO FRANCESCO



Sobrero Winery: passion, love and tradition. An increasing passion, a love that continues to grow stronger, and a great tradition closely tied to the land and the territory. Three words, three creeds, that merge and exist for one purpose only: excellence in wine. Since the 1940 s and the efforts of the grandfather Francesco, the vital breath of the Sobrero Winery continues to be reinforced. From the 1960 s with Settimo and Pier Franco, and Flavio since 2000, the winery has experienced years of continuous growth: from the sale of bulk to bottled wine, from the purchase of new vineyards to the expansion into export markets. The wines produced by the Sobrero family are a constantly ascending parabola, a symbol of the modernity that crosses time without erasing its foundation, the tradition that accompanies the work in the vineyard and the cellar, step after step.

## AZIENDA AGRICOLA FEYLES - SORELLE DE NICOLA

The winery was founded in 1964 by Maria Feyles and Antonio de Nicola, her son-in-law. They first invested in the purchase of the Montesommo vineyard, a parcel of land in the village of Neive, in the heart of Barbaresco production area. Other parcels have been progressively acquired in the Langhe hills, and the company now owns more than 7ha of vineyards.

They are planted mostly with Nebbiolo grapes, along with Barbera and Dolcetto grapes. The family has consistently shown its dedication to tradition, in the vineyards as well as in the winery. The goal has always been to produce distinctive wines, true expression of the grapes and of the local terroir.

Simone Scaletta is a young winemaker who makes his own wine at Monforte d'Alba, one of the 11 Barolo towns. He grows in Locality Manzoni five hectares of vineyards with a natural approach, in full respect of the earth and its fruits. Viglioni, Sarsera, Autin d'Madama and Chirlet are his four vineyards which also give the name to his wines. Dolcetto d'Alba, Barbera d'Alba, Langhe Nebbiolo and Barolo are wines rich of personality and character, made by natural vinification, which follow several decanting at the right moment and a slow fining, without filtering, giving a balanced, authentic and natural evolution.

## SOCIETA AGRICOLA BRIGALDARA

The name Brigaldara appeared for the first time in the deed archives in 1260 and referred to a group of farmhouses, the villa and the surrounding countryside. The Cesari family purchased the villa and the surrounding land in 1929.

At that time, the area was not used only for the cultivation of grapes and olives but was also used for fruit and cereals. In the 1960s and 1970s, with the end of crop-sharing, the land was reconverted to specialise in the cultivation of vines and olives.

## AZIENDA GIOVANNI EDERLE

Already at the age of 18 he decided to start this project, ambitious and partly unconscious: to grub up the old vineyard, now irrecoverable, by laying the new barbatelle and assisting them alone in growth over the next two years. The first small experimental vintage harvest dates back to 2008. I see my work, the fatigue I have done, the friendship of those who helped me, the experience of those who advise me, the patience of those who endured me.

The reason is that the agricultural activity gives me the opportunity to preserve my land for the future, continuing to cultivate unusual terraces, renovating the ancient dry walls and replenishing the old varieties of these lands.

Ours is a controversial love , doubtful, and like all visceral love is beautiful because it pushes you to accept each other for what it is .

We cultivate the vineyards of high vocation in the hills of Faenza near the Oriolo dei Fichi zone, fortified historical site dating back to 1457, among the oldest in Italy .

Total is the respect of the native varieties preserved in the old family vineyards and renovated in the newly developed systems .Sangiovese , Albana , Burson , Centesimino , Famoso , are some of the native varieties grown with respect for tradition .

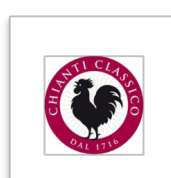

The estate, which had the typical local name of Colombaio, belonged to the Biondi Santi family which achieved one of the best Brunellos of the area from there at the time. Sergio Rossi bought the land in 1976 and completely restructured it respecting its original environment.

Shortly afterwards in 1978, he created and marketed the La Gerla brand.

They care about the health of this land because they transmit the soil that is farmed from one generation to the next. Marotti Campi aim to impact as little as possible on the environment, not using water for irrigation and limit the treatments to those strictly necessary, using low dosage products, hence guaranteeing an equilibrium between the vines and the soil on which they grow.

AZIENDA AGRICOLA PALAZZONE

In 1969 the Dubini family bought the property Palazzone, constructed by Cardinal Teodorico at the bidding of Pope Boniface VIII as a hostel for pilgrims on their way to Rome to celebrate the Jubilee of 1300 A.D.

Today after a restoration with respect for the noble architecture, Palazzone is a boutique hotel with elegant suites. The hilly portion of the land adjacent to Rocca Ripesena, with its superb view of Orvieto on its majestic crag, consisted of sedimentary soil and clay.

Angelo Dubini decided to plant 25 hectares to vines of varieties that he expected would make wine of great complexity and character. In 1982 his two sons, Giovanni and Lodovico, made the first small vintage from these grapes. In 1988 their vintage was sufficient to justify the construction of a winery to process all their own grapes and also to organise and begin the commercial marketing of what is now Palazzone wine regarded as one of the most significant labels in Umbria.

## FATTORIA NICODEMI

Fattoria Nicodemi is in Notaresco, in the heart of the Colline Teramane zone.

The hilly estate covers a single plot of 38 hectares, of which 30 are under vine. The land, at about 300 metres in altitude, is aspected to the south east, with Mount Gran Sasso watching its back, and the sea at about 10 kilometres. At the farm they work with organic practices, with no use of chemical herbicides, pesticides or fertilisers on the vines, preferring spontaneous grassing in the rows. In the same spirit, the new vineyards are planted with a mass selection taken from our heirloom vines.

We believe in biodiversity and even our new vines are selected from our heirloom cultivars, because something that was good in the past can play a role in the future.

The Customer hereby makes application to obtain a Credit Account with Convivium Wine Consultancy Pty Ltd.

Convivium Wine Consultancy may approve the application at their discretion.

Completion of this form does not automatically entitle the customer to a Credit Account.

The account will be 30 Days Net, which means payment is due after 30 days from the date of the invoice. Guarantees must be signed for a Credit Account to be considered or all accounts will be set up as PBD, Payment before Delivery.

The Customer declares that the Liquor Licence information provided on page 1 (marked \*) complies with the Liquor Act 1992 and is correct and current. Any changes must be notified to the Company in writing.

### PAYMENT TERMS

Nett all purchases and freight Payable by the 30th day following the month of invoice. Payment to Convivium Wine Consultancy, without any right of set-off or for part payment, shall be made in cash with the Customer's order. This is unless the Customer completes the Convivium Wine Consultancy Credit application and Convivium Wine Consultancy approves that Application and any conditions relating to that approval are satisfied by the Customer.

Whereupon such Account Customers can make full payment for all invoiced items in any manner stipulated by Convivium Wine Consultancy.

Full terms and conditions of sale and supply of services apply as per Convivium Wine's Price List and Application for Credit forms. Payments shall be made payable to Convivium Wine Consultancy Pty Ltd.

### CLAIMS

All Goods will be at the Customer's risk ex-warehouse. The company can arrange freight (including any additional services) for the Customer unless declined by the Customer. If freight is declined, the Customer must make its own arrangements for delivery of Goods at its own cost. In order to recognise a claim for damage or loss during freight by the company's arranged carriers, the company must be notified at the time of delivery. Claims of any other nature will not be accepted unless made within 24 hrs. of delivery. The company reserves the right to refuse any claim.

### CHANGE OF OWNERSHIP

The Customer agrees to notify the company in writing of any change to ownership of the Customer within 7 days of such change, and indemnifies the company against any loss or damage incurred by it as a result of the Customer's failure to notify the company of any change. The company also reserves the right to withdraw the Customer's approved credit status in relation to the sale of Goods, and all outstanding amounts will become immediately due and payable and future deliveries can only be made by payment of cash on delivery.

### OVERDUE ACCOUNTS

If the Customer fails to make any payment (whether for Goods or separately, for the provision of freight) by the due date, the company may, in addition to taking any other action: (a) charge interest on all overdue payments at four percent (4%) per month from the due date until the date of payment (or otherwise as allowed under the law), and (b) suspend all further delivery of Goods or further performance of any other contract with the Customer.

### PRICES FOR GOODS AND FREIGHT

Prices for Goods and optional freight are subject to alteration without notice. The wholesale price stated in the price list excludes Wine Equalisation Tax (WET) but includes a component for freight arranged by the company under a separate contract, unless freight is declined by the Customer. The LUC price doesn't include amounts for the following separate charges: (i) goods and WET under a separate contract; and (ii) Freight under another separate contract.

All Goods and freight (unless declined) are subject to GST. WET is calculated on the price of wine only unless exempt. Freight will be arranged by the company under a separate contract (at the customer's option) and be charged to the Customer's account; such costs are not included in the LUC price.

Where the customer declines freight, the customer must advise the company beforehand so that arrangements can be made for reasonable access for the customer to pick up the goods at the company's warehouse and/or offices. In these circumstances the freight charge will not apply. Freight charges above are calculated as a flat-rate ex-warehouse but only for minimum quantities of 2 dozens.

### RETENTION OF PROPERTY

Property in goods sold by Convivium Wine Consultancy will not pass to the Customer until the earlier of: Payment in full of the price of the goods inclusive of any GST (excluding any freight charge and other fees, where applicable); and sale by the Customer to a bona fide purchaser in the ordinary course of the Customer's business.

The Customer acknowledges and agrees that a continuing purchase money security interest is created by this retention of title provision granted by the Customer to the company, as the secured party, over the goods sold to the Customer.

Where the Customer sells the goods to a bona fide purchaser in the ordinary course of Customer's business the Customer acknowledges and agrees the continuing purchase money security interest extends to all and any proceeds of the goods and this continuing purchase money security interest attaches to the goods and all and any proceeds of the goods as at the date the Customer signs this Application for Credit Account. The Customer will continue to ensure the company's priority against any subsequent security interest and/or purchase money security interest over the goods and/or proceeds where the Customer is the grantor of that



security interest. The above retention of title clause is subject to the following conditions:- i) The Customer, for the purposes of preserving the company's interests, will on receipt of its goods ensure such goods are kept separate from that stock fully paid (the other stock) where the Customer has clear property or title in the goods; (ii) Such demarcation of stocks shall continue until the company's stock has been fully paid for by the Customer;
